

PERMANENT COURT TIME (P.C.T.) AGREEMENT

2011-2012 FULL SEASON (September - May) Non-Cancellable

The Captain should list all players, each player's percentage (TOTAL MUST = 100%), and the Total amount due for each group's P.C.T. Although individual players are billed, the Captain is responsible for payment of P.C.T. fees to the Centre and any outstanding amounts may be billed to any/all of the Members of the PCT Group at the Centre's discretion. If a player drops from a PCT Group, they must either continue to pay their %, get a substitute to take over their spot, or their % of billing will be billed to the group. **After June there will be charges for any and all billing changes of % and/or players, or the Captain may collect all dollars and pay the Centre. Seniors, 65 & older, may receive a 15% reduction in their PCT bill. Please let us know of all seniors in your group.**

This agreement is made between The Racquet Club of Oak Park-River Forest, an Illinois limited Partnership, d/b/a The Tennis and Fitness Centre of Oak Park-River Forest (**TFC**), and the Member identified below (Captain), who is responsible for each P.C.T. time shown above. In addition to any and all remedies, the discounted PCT Rate shall be forfeited and court fees shall increase to the then posted Open Court Time Rate, for all unpaid court times, if outstanding PCT payments have not been received in full within 30 days of date of billing. The Captain **verifies** all Players listed above are Members, agrees to the P.C.T. above, will abide by all terms and conditions of the Agreement, and will pay all costs of collection, including reasonable attorneys fees, incurred by **TFC** in enforcing or attempting to enforce any of its provisions.

PERMANENT COURT TIME (PCT) AGREEMENT

1. All Permanent Court Time (PCT) players must have paid current memberships at The Tennis and Fitness Centre of Oak Park-River Forest (**TFC**), before their first week of play. PCT is only available to Members in good standing of **TFC**. If a PCT player's membership terminates during the PCT season, the player forfeits their rights to all **TFC** privileges, including PCT, but remains responsible for full payment of the PCT. No refunds will be given for PCT, but the terminated Member may sell their remaining PCT to a Member in good standing of **TFC**.
2. PCT reservations are made for the same time each week during the approximate 38 week season beginning Tuesday, Sept.6, 2011 thru Fri., May 25, 2012. This PCT Agreement **excludes** billing on the following holidays: Thanksgiving Day, Christmas Eve all day, Christmas Day, New Year's Eve after 5 p.m., New Year's Day, and Easter.
3. PCT payments may be paid with a deposit from the Captain of the PCT group, and two installments. The deposit is to accompany the application for each group. The first installment must be paid before play begins. The second installment will be billed around December and is due on January 1st 2012. **All fees must be current and the Membership and the first installment of PCT must be paid by October 1st and the second installment paid by February 1st or the discount for PCT will be removed for the entire Season and the PCT group will forfeit the privilege to pay in two installments and agrees to pay the full PCT amount for the entire year immediately along with a \$20 service charge and finance charges; All in the sole judgment of TFC. TFC courts may not be used after Oct. 15, 2011 and after February 15th unless all amounts for each installment are current.** All PCT amounts, not paid by dates specified, shall be subject to a Finance Charge on the amount due at compounded monthly periodic rate of 1.5% from the date due (Annual Percentage rate of approximately 19.6%). In addition to other remedies stated herein, failure to comply with the payment schedule within 30 days of billing date may result in suspension/cancellation of Membership and/or PCT without notice, and **TFC** reserves the right to all additional remedies as provided by law. **TFC** may also bill the other players for the past due funds of the late/non-paying player.

PERMANENT COURT TIME (PCT) CANNOT BE CANCELLED DURING THE SEASON.

4. Through June 30, 2011 (**renewal holding date**), PCT for the 2011-2012 season will be offered in the following order/priority: **a.** 2010-11 PCT holders requesting renewal of their **same PCT** used in the 2010-11 season. **b.** Existing members requesting new or additional PCT times. **c.** New members joining **TFC**.
5. Requests for new or additional PCTs are scheduled, after the "renewal holding date," in the order received at **TFC**.
6. **TFC** reserves the right to assign any court to each PCT group and adjust times eliminating time gaps. Without cause, **TFC** may make this substitution, beyond which **TFC** will have no other responsibility or liability.
7. This PCT agreement must be filled out completely and signed by the Captain of each group and include the names of all players in each group. Changes occurring after this application must be immediately reported to **TFC** by the Captain. **Captain agrees to promptly pay all fees uncollected by TFC from guests and the group.**
8. **The Captain of each group must maintain TFC membership in good standing throughout the 2011-12 Season and submit this completed form with a non-refundable deposit of \$50.00 per court reservation.**
9. PCT reservations are for the entire season ending May 25, 2012. **PCT CANNOT BE CANCELLED during the season** without written approval from **TFC**. If approval of a cancellation is granted by **TFC**, a \$50.00 service charge will be paid by the Captain and/or the deposit will be forfeited to **TFC**. If computer or billing changes are required after June 30, the Individual or Captain will be charged \$20.00 per change. To avoid this fee, the captain may "settle up" the PCT costs between the members of the group and make the full payment(s) to **TFC**.
10. If PCT holders wish to sell their court time for any week, the Captain should notify **TFC** as far in advance as possible. **TFC** must be notified and asked to "sell" the court, and court must be sold at the full rate (Jr. walk-on rates are not full rate) for the holders to be credited for their time less a \$5.00 charge.
11. Substitute Players ("**SUBS**") for a PCT group must be Members of the Centre and in good standing. It's the responsibility of the Member extending the invitation to SUBS to verify the Membership status of the SUB (call **TFC**). **A Non-Member may be a SUB only upon payment of the Guest fee prior to play and no more than five guest visits are allowed to TFC by any Guest at the reduced Guest Fee rate. After five (5) Guest Visits the full rate of thirty five dollars (\$35) per visit shall apply.** Any Guest and any and all Guest privileges may be denied and/or revoked at any time and for any reason by **TFC**. The Captain, and/or the PCT Players in the PCT Group listed herein shall be responsible to immediately pay all charges plus late fees for failure of the Guest to pay all fees in full.
